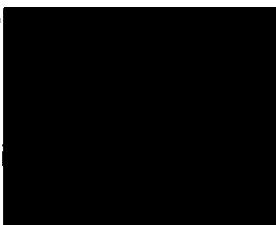

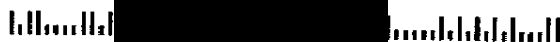

Unless you pay or file a protest of the amounts shown with the Department of Revenue within 60 days of the date of this notice, the amounts shown above will automatically become a final assessment without further notice to you. **Failure to pay or file a protest of these amounts within 60 days will result in a collection action against you and may result in a suspension of your professional license held in Missouri pursuant to Section 324.010 and 484.053, RSMo.** A Certificate of Tax Lien may be filed with the Recorder of Deeds, resulting in a lien against all of your real and personal property. A Certificate of Tax Lien may also be filed with the clerk of the circuit court, which will have the full force and effect of a judgment against you.

**MAIL CHECK OR MONEY ORDER TO THE MISSOURI DEPARTMENT OF REVENUE.** If you pay by check, you authorize the Department of Revenue to process the check electronically. Any check returned unpaid may be presented again electronically. You may charge the balance to Mastercard, Discover, American Express, or Visa by calling toll-free (888) 929-0513. A convenience fee will be charged to your account for processing.

Thank you for your letter regarding your 2003, 2004, and 2005 Notices of Deficiency.

Pursuant to Section 6103(d) of the Federal Internal Revenue Code, the Internal Revenue Service (IRS) notified the Missouri Department of Revenue (Department) of changes to your federal adjusted gross income for 2003, 2004, and 2005. As the Department had no record of you filing a Missouri income tax return for the above mentioned tax years, Notices of Proposed Changes were sent to you for each period on October 10, 2008.

Each notice reported an adjustment was made by the IRS and requested you file Missouri returns or pay the estimated liabilities calculated by the Department. As no response was received, Notices of Deficiency were issued for each period on November 26, 2008.

The Department has received your protest of the Notices of Deficiency. The Department will issue a Final Decision as required by Section 143.641, RSMo.


Your total balance due is \$21,426.16. This amount consists of \$6,728.46 for tax year 2003, \$6,626.49 for tax year 2004, and \$8,071.21 for tax year 2005. Interest has been calculated through February 10, 2009, and will continue to accrue until the balance is paid in full.
