

# PASSPORT AMENDMENT REQUEST FORM INSTRUCTIONS

Last revised: 5/26/09

## 1. **PURPOSE:**

- 1.1. Those who wish to become Members of our Ministry are required by the following document to correct all government records reflecting their citizenship status, including their passport:

*Path to Freedom*, Form #09.015  
<http://sedm.org/Forms/FormIndex.htm>

- 1.2. Unfortunately, some people seeking to become Members or who have already become Members:
- 1.2.1. Already have an existing passport received before discovering our website.
  - 1.2.2. Seek to amend their existing passport without applying for a new one.
- 1.3. This form allows those who *already* have existing USA passports to update the original application without applying for a new passport in order to develop evidence of their correct citizenship status that they can subsequently use in court.

- 1.5. **NOTE:** Do not use form DS-19 with this application. Use of that form was discontinued in 2005. The proper procedure to update passports is found at:

## 2. **PROCEDURE FOR USE:**

- 2.1. The form is electronically fillable with the free Adobe Acrobat Reader available below. Please download and install the latest version of the program:

- 2.2. If you want to obtain a copy of the original passport application, the instructions for doing so are found at:

- 2.3. Fill in the return address and date on the cover letter with yours.
- 2.4. Fill in the destination address on the cover letter off the Department of State Website:

- 2.5. Fill in the name at the end of the cover letter.
- 2.6. Print out the document on double-sided paper to keep the size down.
- 2.7. Obtain a photocopy of your current USA passport, preferably in full color. Attach behind the cover page for Enclosure (1).
- 2.8. Download and print the following form and attach behind the cover page for Enclosure (2):  
*USA Passport Application Attachment*, Form #06.007

- 2.9. Find a Postal Annex or UPS Store that has two people on duty, one of which is a notary and the other the Mail Server who will mail the item and complete the Certificate of Service.
- 2.10. In the presence of the Notary and using blue (not black) ink, sign section 3 of the document and the end of Enclosure (2).
- 2.11. Have the Mail Server fill out the attached Certificate of Service and sign it. Make sure item 2 includes the addresses where the items are mailed, as indicated in the Cover Letter.
- 2.12. Have the Notary fill out the Notary Public Jurat at the end of the Certificate of Service, which authenticates the identity of the Mail Server.
- 2.13. Make one copy of the entire package, including:
- 2.13.1. Cover letter
  - 2.13.2. Enclosure (1): Photocopy of Current Passport
  - 2.13.3. Enclosure (2): USA Passport Application Attachment
- 2.14. Have the Mail Server put the *copy* into the envelope, and then seal the envelope and personally drop them into the mail.

2.15. Keep the original for yourself and make several copies. You also might want to record the original with the County Recorder so that it becomes a public record which is automatically admissible as evidence in any court trial. The reason is that under [Federal Rule of Evidence 902](#), public records are not subject to the Hearsay Rule.

3. **PROTECT YOUR LEGAL EVIDENCE.** Keep the original in a safe place locked up, preferably away from your house so that it may not be seized. Also, scan it in as a full color PDF and make backups you keep in several locations. One of the first things a judge will do if you want the document admitted as evidence in a legal trial is ask about the chain of custody of the document and whether it has remained under your own control at all times so that there is an assurance that it was not tampered with. 11 **1 PURPOSE:**

12 This correspondence constitutes a correction/amendment to the original DS-11 passport application which gave rise to the  
13 issuance of the passport described in Enclosure (1). I am providing this information because:

- 14
- 15 1. I want to ensure that the records you have about me are as complete, accurate, and unambiguous as humanly possible.
  - 16 2. The original DS-11 form submitted to you which gave rise to my current passport contained information that I now  
17 know, based on subsequent legal research AFTER submitting it, is either inaccurate or which could encourage or  
18 condone false presumptions about my legal status that might have criminal consequences.
  - 19 3. I want to avoid any possibility of ever being accused of committing perjury on the passport application, and avoid any  
20 adverse consequences arising from conflicts between the status or information I claim in current/recent government  
21 correspondence and forms, and the status I mistakenly and unknowingly claimed at the time the original DS-11 was  
22 submitted.
  - 23 4. To ensure that I am not held to a higher standard of accountability than the government itself on forms which I have  
24 peviously submitted to the government. The government almost never authenticates its correspondence under penalty  
25 of perjury.

26 **2 ACTION PROMPTLY REQUESTED OF YOU**

27 Please promptly:

- 28
- 29 1. Attach and associate this correspondence and all enclosures with the original DS-11 application in order to ensure that  
30 my original application is not misconstrued or viewed as inaccurate.
  - 31 2. Remove any government identifying numbers associated with my name, including Taxpayer Identification Numbers  
32 (TINs) and Social Security Numbers. I AM NOT eligible and never have been eligible for any government identifying  
33 numbers and any numbers in your possession are NOT my number, but instead belong to the government. It is a  
34 CRIME to use such public property for a private use or private purpose, and I was a private person not engaged in  
35 federal franchises at the time I made application for a passport. See and rebut ALL of the following promptly if you  
36 disagree:

  - 45 4. Update my parent's citizenship status indicated in block 10 of the DS-11 form from "U.S citizens" to non-citizen  
46 nationals pursuant to 8 U.S.C. §1101(a)(21) and 8 U.S.C. §1452.
  - 47 5. If you dispute or have doubts about anything in this correspondence, please read and then respond with a detailed  
48 rebuttal signed under penalty of perjury to:
    - 49 5.1. Anything you disagree with in this correspondence.
    - 50 5.2. Anything referenced in this correspondence.
    - 51 5.3. Anything inaccurate in the following, and especially the questions at the end of the following:

1 I ask that in responding to this correspondence, you avoid the temptation to:

- 2
- 3 1. Make legal determinations about my status. I do not authorize you to practice law on my behalf or to tell me either
- 4 what I AM or what I am NOT. The status I claim is an exercise of my protected First Amendment right of freedom of
- 5 association and you may not interfere with the exercise of that right by telling me how, or under what circumstances, I
- 6 choose to politically associate or disassociate with a specific political group called a "state" or government.
- 7 2. Label anything within this correspondence as "frivolous". For the purposes of your response to all correspondence or
- 8 forms originating from me, that word shall mean "truthful, accurate, and consistent with prevailing law". I emphasize
- 9 that you are a public **servant** and I am the public. You serve me and I have a right to expect that you will help me
- 10 comply with the requirements of law by citing HOW to comply, not why you don't like my sincere efforts to comply.
- 11 3. Try to compel me to participate in federal franchises such as Social Security, Medicare, Unemployment, or the "trade
- 12 or business" franchise that is the heart of the income tax. It is a criminal violation of the separation of powers and the
- 13 Thirteenth Amendment to offer or enforce government franchises to those domiciled outside of federal territory or
- 14 those not ALREADY lawfully employed with the federal government as public officers BEFORE they filled out any
- 15 tax or passport form. See 18 U.S.C. §911 and the rebut the following and the questions at the end of the following if
- 16 you disagree:

19 I emphasize that the original DS-11 form constitutes "testimony of a witness" because signed under penalty of perjury and

20 that a failure to add this correspondence in its entirety to the original DS-11 application submitted for my current passport

21 will result in the following crimes on your part and/or make you a willful accessory to such crimes:

- 22
- 23 1. Perjury. 18 U.S.C. §1001, 18 U.S.C. §1621.
- 24 2. False statements on a passport. 18 U.S.C. §1542
- 25 3. Subornation of perjury. 18 U.S.C. §1622.
- 26 4. Misprision of felony. 18 U.S.C. §4. You are required as a public officer to report any and all crimes indicated above
- 27 that are caused by an omission or inaction on your part.

28 You have 30 days to respond to and rebut this correspondence. Beyond that point, each item not so rebutted:

- 30 1. A default and equitable estoppel pursuant to Fed.Rul.Civ.P. 8(b)(6).
- 31 2. An admission of everything not expressly rebutted.

32 A response not signed under penalty of perjury or signed without the real legal birthname, work address (NOT PO BOX),

33 phone number, and place where you can be served with legal papers shall constitute a non-response for the purposes of this

34 correspondence. You have absolutely no business telling me that I am wrong if you refuse to take complete, exclusive, and

35 personal legal responsibility for your statements and actions. Every time I correspond with you on a government form, I

36 have to sign it under penalty of perjury and you have to abide by the same rule. Otherwise, an unconstitutional "title of

37 nobility" has been illegally conferred and the requirement for equal protection that is the foundation of the Constitution has

38 been violated.

### 39 **3 AFFIRMATION**

40 I certify under penalty of perjury from without the "United States" and from within the "United States of America", a

41 foreign state and a foreign estate pursuant to 26 U.S.C. §7701(a)(31) and 28 U.S.C. §1746(1) that this correspondence and

42 all enclosures are true, correct, and complete to the best of my ability when accompanied by the original DS-11. I also

43 certify that my original DS-11 was not knowingly false at the time I submitted it may be wrongfully construed as false if it

44 is not promptly updated as indicated by this enclosure.
