

# ***DENIAL OF APPLICATION AND DISCRIMINATION AFFIDAVIT FORM INSTRUCTIONS***

Last revised: 9/22/07

## **1. PURPOSE:**

- 1.1. To develop court-admissible evidence relating to occasions when you submitted any one of the following types of applications without a Social Security Number or Taxpayer Identification Number and were discriminated against or denied a service, benefit, or business opportunity because of your failure to disclose or use a Social Security Number:
  - 1.1.1. Department of Motor Vehicles driver's license application.
  - 1.1.2. Private employment application.
  - 1.1.3. Financial institutions account application.
  - 1.1.4. Business contract.
  - 1.1.5. School forms and documents.
  - 1.1.6. Rental application
- 1.2. Occasions when the completed version of this form is intended to be used:
  - 1.2.1. If you are stopped by a traffic officer and are driving without a license because the DMV wouldn't issue you one. This form proves that you made an attempt but were denied.
  - 1.2.2. In traffic court to prove to the judge that you were denied a license. This is especially helpful if you were ticketed for driving without a license.
  - 1.2.3. In court litigation to prove the existence of discrimination so you have standing to sue the party who instituted the discrimination.
- 1.3. This form is useful in combination with the following forms, which is what you present to the recipient of your application of they disagree that you are eligible:

## **2. PROCEDURE FOR USE:**

- 2.1. When you have completed the application associated with this denial notice, it is best to have a friend mail it to the recipient via Fedex or deliver it in person. That person will be your neutral witness in court. If you deliver it via mail, we recommend the following:

- 2.2. In the application associated with this notice that you expect to be denied, it is best to emphasize that any denials should be in a signed writing with the reasons for denial specified. This will provide evidence documenting the existence of the discrimination.
- 2.3. If you are going to make the application in person, it is best to have a friend with you as a witness who can observe what was said about the reasons for rejection. Ensure that:
  - 2.3.1. The friend is present for everything that is said when you presented the application.
  - 2.3.2. The recipient of the application doesn't try to separate your witness so that they can talk privately with you about their reasons for rejection.
- 2.4. Fill out sections 1 and 2.
- 2.5. Your witness should fill out section 3 through 5.
- 2.6. After your witness completes sections 3 through 5, he should find a notary and sign the form in the presence of the notary.
- 2.7. The notary should then notarize the identity of your witness in Section 6 so that your evidence becomes immediately admissible.
