But you have not obeyed Me. Why have you done this?

"Therefore I also said, '<u>I will not drive them out before you; but they will become as thorns [terrorists and persecutors] in</u> your side and their gods will be a snare [slavery!] to you.'''

# 1 **INTRODUCTION**

This document summarizes what we call the Ten Commandments of Freedom. These commandments are intended to keep you out of trouble and on a solid footing in all your interactions with governments around the world.

- These commandments are patterned after the Ten Commandments found in the Holy Bible at Exodus 20. The original commandments have been modified to place them in contemporary American terms.
- Chapter 3 of this document describes the real life application of each commandment, how the
   commandment is violated, and authorities relating to remedies available to prevent the violations

# 2 <u>SUMMARY OF THE TEN COMMANDMENTS</u>

- You shall have no man-made laws before the Creator's laws. You shall not look to the government as your Savior nor put legislative statutes above my law. The Declaration of Independence recognizes supremacy of the Creator's law as the source of all law and rights. Do NOT consent to be a slave to your servant government's statutory laws.
- You shall not worship or serve any man, politician, government, president, statute, creation of men,
   <u>flag, or other graven image</u>. Be jealous of and do not surrender your power or sovereignty over
   your politician servants.
- You shall take oaths in God's name only, shall honor your oaths, and shall not use God's name in
   vain. You shall not tolerate contract breakers or those who compel contracting with government
   through abuse of franchises. You shall confess the true God and show allegiance to ONLY Him.
   No man can serve two masters or take oaths to more than one master.
- 4. You shall keep the "First-day Sabbath" of Freedom (July 4<sup>th</sup>) and not permit the government to
   enslave and control you.
- <sup>15</sup> 5. <u>You shall honor your father and mother</u>. You shall protect your family with lethal force from
   <sup>16</sup> "swarms of officers" that charge, indict, fine, and imprison people in a commercial schemes
   <sup>17</sup> designed to transfer wealth from the family to the State.
- 6. <u>You shall not murder</u>. You shall vigorously protect innocent life (including the unborn) with lethal
   force, but you must also possess vigorous, moral energy to apply the death penalty to those who
   wrongfully take innocent life. Both the protection of life and the taking of life are religious duties
   of man.
- You shall not commit adultery. You are to keep your marriage contracts and protect your family
   from personal transgressions as well as from a government that sanctions fornication, adultery, and
   sodomy. Adultery includes both sexual adultery and commerce with government.
- 8. <u>You shall not steal</u>. You shall not permit your neighbor to steal; nor permit your government to steal under color of law in a sophisticated tax scheme.
- 9. You shall not bear false witness. You shall not lie about your status on government forms or allow others to lie about your status or presume a status you don't expressly consent to. You shall not lie about your neighbor in court nor tolerate being a victim of lies; nor shall you allow yourself to be manipulated by clever and deceitful schemes designed to make you a "human resource" for the benefit of the government.
- You shall not covet your neighbor's property. You shall not allow yourself or your neighbor to fall
   prey to a commercial plot or taxation scheme, a.k.a. constructive fraud, designed to impoverish
   you and your neighbor in order to increase the wealth and holdings of the government or a
- <sup>35</sup> financial elite.

# **3** APPLICATION OF EACH COMMANDMENT

# 2 3.1 You shall have no man-made laws before the Creator's laws

BACKGROUND: You shall not look to the government as your Savior nor put legislative statutes above my law. The Declaration of Independence recognizes supremacy of the Creator's law as the source of all law and rights. Do NOT consent to be a slave to your servant government's statutory laws. The purpose of this commandment is to prevent worship of gods that DON'T exist or things that the Creator created.

- Constitutional and natural rights attach to LAND while franchise PRIVILEGES attach to a statutory
   status. Consequently:
- 1.1. You don't need to be a "citizen", "resident", or "inhabitant" to have constitutional or natural rights.
  - 1.2. If you were standing on land protected by the constitution, you don't need statutes or a domicile to claim an injury in a constitutional court under the common law.
    - 1.3. PRIVILEGES can only be acquired by your consent. If you never consent or contract with the government, you can't be party to the franchise contract that implements the privilege.
- <sup>16</sup> 2. <u>The ability to regulate PRIVATE rights is repugnant to the Constitution</u>. Hence:
  - 2.1. All government civil statutory law can and does regulate PUBLIC conduct of PUBLIC officers.
  - 2.2. A government which asserts a right over specific property has the burden of proving on the record of the proceeding the existence of consent to convert the property from PRIVATE to PUBLIC property or to convert ownership of the property from ABSOLUTE to QUALIFIED.
- 21 Examples of violations and their remedies:

- <u>VIOLATION 1.1</u>: By asking the servant for permission in form of a license to marry or work or
   engage in commercial activity. For example, buying a gun, professional licenses, etc.
- 1.1. <u>REMEDY 1.1</u>: Don't ask your servant for permission by applying for licenses because the
   constitution gives you the right to contract and associate with others without government
   permission. All licenses and franchises substitute the franchise contract in place of God's law
   and thereby supersede God's law. Only two people can marry and the government cannot
   interfere with that contract. Art. 1 Section 10. Only slaves need permission and direction
   from their master to work. By engaging in commercial activity, you are engaging in the
   private law of contracts, which existed before government.
  - 1.2. AUTHORITIES 1.1:

- <u>VIOLATION 1.2</u>: By agreeing to be prosecuted for a FAILURE to do something such as file a tax
   return or get a license. A failure to do something is not a crime and can only be prosecuted as a
   consequence of consent, a contract, or a franchise.
- 42 2.1. <u>REMEDY 1.2</u>: By demanding that they demonstrate the existence of duty that you consented
   43 to by contract or agreement under the First Amendment.

BACKGROUND: Be jealous of and do not surrender your power or sovereignty over your politician servants. Do not consent to surrender your absolute right of equality of treatment in relation to any and every government or collective. The purpose of this commandment is to prevent worship of creations of men.

1. The origin of the authority of all government to civilly govern is the EXPRESS consent of the 10 governed, according to the Declaration of Independence. 11

- 4. Government franchise courts cannot hear cases against those who didn't lawfully consent to the 39 franchise. This is an unconstitutional Bill of Attainder. Franchise courts include but are not 40 limited to traffic court, family court, and tax court. 41

- 1. VIOLATION 2.1: By cooperating with, subsidizing, or consenting to any effort by the government 1 to enforce an authority that you the sovereign have not delegated to them. A sovereign can only 2 delegate a power that it has and the government cannot assume a power that is not expressly 3 delegated in writing. 4 1.1. REMEDY 2.1: By demanding the written delegation of authority and without it refusing to 5 CONSENT to assumed authority that has not been expressly demonstrated with written legal 6 evidence. 7 1.2. VIOLATION 2.4: Using politicians as role models for your behavior or that of your family. 20 Example: Thinking that the English royal family is a model family. 21 4.1. REMEDY 2.4: Using the Bible as the ABSOLUTE standard for moral or virtuous behavior. 22 4.2. AUTHORITIES 2.4: Exodus 20:5 23 5. VIOLATION 2.5: Recognizing or cooperating with any attempt to define "State" as either a 24 corporation or as anything other than THE SOVEREIGN PEOPLE within a specific jurisdiction. 25 5.1. REMEDY 2.5: Defining the terms "State", and "United States" as the Sovereign People and 26 not any government or servant within a government. Judges frequently try to define or treat 27 the "State" as a federal corporation in commerce rather than a body politic of Sovereign 28
  - People. Asking which of the two "States" is being represented in the proceeding: the "body politic" or the "body corporate". It can only be one.

# 1 3.3 You shall take oaths in Creator's name only, shall honor your oaths, and shall not use 2 God's name in vain

BACKGROUND: You shall not tolerate contract breakers or those who compel contracting with government through abuse of franchises. You shall confess the true Creator and show allegiance to ONLY Him. No man can serve two masters or take oaths to more than one master.

- <sup>6</sup> Examples of violations and their remedies:
- <u>VIOLATION 3.1</u>: Participating in the pledge of allegiance, and especially if pledges to the Creator are prohibited in the same situation.
- 1.1. <u>REMEDY 3.1</u>: Do not participate in the pledge of allegiance. Step out of the room and say a prayer and a pledge to God instead of government.
  - 1.2. AUTHORITIES 3.1:

- <u>VIOLATION 3.2</u>: Signing a perjury oath on a government form. All perjury oaths define the laws under which the oath is taken, and that law in turn always ends up being law for government and not private human beings. Thus you are volunteering for a government job by taking an oath.
- 2.1. <u>REMEDY 3.2</u>: Define the words in the perjury oath or the entire oath paragraph to give it a
   meaning that places you OUTSIDE the jurisdiction of laws limited to government and places
   you under the common law and God's law ONLY.
  - 2.2. AUTHORITIES 3.2:

- 4.1. <u>REMEDY 3.4</u>: When acting as a court witness and the judge or government attorney
   interrupts your attempt to state things he didn't ask about, filing a criminal complaint against
   the party and making sure the jury knows that the crime of subornation of perjury has been
   committed.

- 5. <u>VIOLATION 3.5</u>: When submitting a government form verified by perjury or oath, failing to
   define all the terms on the form so as to leave room for the judge or government actor to define
   them in conflict with what you intended on the form or so as to bring you within the jurisdiction of
   the government.
- 5.1. <u>REMEDY 3.5</u>: When acting as a court witness and the judge or government attorney
   interrupts your attempt to state things he didn't ask about, filing a criminal complaint against
   the party and making sure the jury knows that the crime of subornation of perjury has been
   committed. Nearly all the criminality that corrupted governments get away with results from
   filtering the WHOLE truth out of the legal or administrative proceeding to make it at least
   "appear" lawful. Instead, state on the form or when called as a witness:

"This form is false, fraudulent, and perjurious unless accompanied by all \_\_\_\_ enclosures, consisting of \_\_\_ pages."

<u>BACKGROUND</u>: You shall protect your family with lethal force from "swarms of officers" that charge,

BACKGROUND: You shall vigorously protect innocent life (including the unborn) with lethal force, 2 but you must also possess vigorous, moral energy to apply the death penalty to those who wrongfully 3 take innocent life. Both the protection of life and the taking of life are religious duties of man. 4

- Examples of violations and their remedies: 5
- 1. VIOLATION 6.1: Abortion. You bow down to politicians (commandment 2) when a woman 6 conspire with a physician as an accessory to have her half born child murdered. This is an 7 unlawful commercial contract. 8

#### 3.7 You shall not commit adultery by having intercourse in commerce with any government 16

BACKGROUND: You are to keep your marriage contracts and protect your family from personal 17 transgressions as well as from a government that sanctions fornication, adultery, and sodomy. Adultery 18 includes both sexual adultery and commerce with government. Black's Law Dictionary defines 19 "commerce" as "intercourse": 20

- "Commerce. ...Intercourse by way of trade and traffic between different peoples or states and the citizens or inhabitants thereof, including not only the purchase, sale, and exchange of commodities, but also the instrumentalities [governments] and agencies by which it is promoted and the means and appliances by which it is carried on... [Black's Law Dictionary, Sixth Edition, p. 269]

- 1. VIOLATION 7.1: Signing up for government "benefits", franchises, or licenses of any kind. 27

# 14 **3.8** <u>You shall not steal</u>

BACKGROUND: You shall not permit your neighbor to steal; nor permit your government to steal
 under color of law in a sophisticated tax scheme.

- 17 1. The foundation of property rights is the right to exclude ANYONE and EVERYONE from using or
- benefitting from the property. Anyone who claims to be a government and yet does any of the
   following is committing FRAUD and acting as an ANTI-government, de facto government,
   terrorist, and THIEF:
- 1.1. Allows you to exclude everyone BUT them from using or benefitting from the property.
- 1.2. Prevents or interferes with ABSOLUTE ownership of a thing.
- 1.3. Claims the right to tax or regulate the use of the thing absent your express consent.
  - 1.4. Interferes with recording PRIVATE transfers of land or personal property.
- Real governments are created to protect PRIVATE rights. The very first step in protecting private
   rights is to PREVENT them from being converted into PUBLIC rights or PUBLIC property
   WITHOUT the express consent of the owner. A government that won't prevent that kind of
   conversion is no government at all, but a THIEF that has no claim to our allegiance or support.
- <sup>29</sup> 3. It is THEFT to convert a CONSTITUTIONAL RIGHT into a STATUTORY PRIVILEGE.

# 1 4 <u>COMMANDMENTS OF SLAVERY</u>

   showing mercy unto millions that contract with me and keep all my statutes; and,
- Thou shall not take the name of Government in vain or speak despairingly of your career
   politicians; for the High Priests of the State and our deacon lawyers will not hold him innocent that
   fails to obey public policy; and,
- Remember election days and keep them holy. Seven days a week shalt thou labor to support the
   State. But, every two years there shall be a voting day to the Lord Government: in it, thou shall
   take off from thy job, you and your children, and fellow slaves, and cattle, and dogs, and those in
   the grave to cast thy vote; and,
- 5. Honor your president and congressmen and legislators and members of the BAR that their reign
   may be long upon the earth which the State has taken from thee; and,
- 6. You shall not murder your civil rulers or police officers who spread statism and democracy, but
  you shall support state sanctioned assassination by Navy Seals in faraway lands and state
  executions of radical anti-government, anti-abortion, anti-homosexual, anti-imperialistic Christian
  citizens who home school their sons and daughters and who don't believe in the authority of the
  state over the life, liberty, and property of their children and great grandchildren and great, great
  grandchildren; and,
- 7. Thou shall not oppose adultery, divorce, fornication, sodomy, pornography, pedophilia, incest,

- consider your civil rulers exempt from truth telling because it might threaten national security; and, 10. They shall not expert your experiment or hear hear they have an taxes or wife or shildren or
- 10. Thou shall not covet your own income or keep back thy house or taxes or wife or children or
   possessions or cars or anything of thy neighbors for everything belongs to the Government.
